## Eligibility

Students are eligible during and after their spring 2L semester, due to a field placement credit limit prior to that semester. Up to two students can participate each semester. Only 2L and 3L students can participate, but students can apply during their 1L year.

#### **Tuition and Fees**

Students do not pay extra tuition to participate in the program, students continue to pay tuition to your home institution. Berkeley Law students are required to pay Columbia the same facilities, student activities, and health services fees that Columbia students pay, which is approximately \$1,400 in total (fee amounts subject to change; see below for 2024-25 semesterly fee breakdown as an example). To account for this, non-Columbia universities and graduate programs with which CPRL partners typically waive their comparable fees for the semester in which their students are in residence at Columbia. \*All full-time domestic students and all international students, regardless of registered credits, are automatically enrolled in the Columbia Student Health Insurance Plan (the Columbia Plan). In order to request a waiver from mandatory enrollment in the Columbia Plan, students must have alternate coverage that meets the University requirements. Students must provide sufficient information regarding their alternate health insurance plan to allow independent verification that the alternate plan meets the University requirements.
