

# CPRL Scholar Award and Employment Verification Process

Financial Support for CPRL Participants

#### CPRL Scholar Award applicants must:

- Submit a completed application for the CPRL Scholar Award and the full-semester program
- Complete a <u>Financial Aid Data form</u> the semester prior to your participation in CPRL
  - Form must be signed/certified by your home school's Financial Aid Office
- Complete CPRL's full-semester program during the fall or spring term
- Commit to work qualifying employment for three of the first five years after graduating from their professional program in a full-time role.\*

What happens if I don't meet the terms of the CPRL Scholar Award?

The CPRL Scholar Award automatically defaults to a loan if the terms, outlined in the promissory note, are not met. The award plus interest (the interest rate for each year after the note is signed is 5%) must be repaid to CPRL in full, prorated for any time period in qualifying employment.

#### WHAT IS THE CPRL SCHOLAR AWARD?

The CPRL Scholar Award recognizes exceptional students who commit to work for three of the first five years after graduating from their professional program in a full-time governmental or non-profit position in PK-12 public education OR in a position in support of PK-12 public education sector.\* Employment can take place in and/or outside the United States. Award amounts are based on your financial need, merit, and the amount of funding available during the term. Financial need is certified by your home institution's Office of Financial Aid. Scholars must accept the terms of the award as outlined in the promissory note. Scholars must attend an entrance and exit interview prior to accepting the award and at the end of the semester to review the terms of their scholarship and preview the Employment Verification process. The Award is processed during the student's participating semester as a scholarship via their home institution. CPRL works with our partner institutions so that scholarships are processed near the beginning of the semester. However, please note that delays can happen, and we cannot guarantee any timeline.

#### TERMS OF THE CPRL SCHOLAR AWARD

CPRL Course Completion

Completion of the Structural Change in Public Education course offered by CPRL and reception of a passing grade reflected on your transcript.

On-time graduation from home institution

Obtain a degree from your home institution fulfilling all outstanding graduation requirements within the timeperiod provided by your home institution.

Scholar Award Entrance and Exit Counseling

Meet with CPRL staff to learn about the terms of your reward before signing the agreement and review the terms of your award after signing.


Submission of annual <u>employment verification forms</u> (EVF) to cprl@law.columbia.edu

You and your employer complete the EVF form to note qualified and non-qualified employment for CPRL's records. Return your completed EVF by sending it to cprl@law.columbia.edu.

Three years of qualified employment completed within the first five years after graduating from their professional program.

Full-time (35+ hours) employment primarily serving the public education of preK-to-high school students, or in a public or non-profit organization in a role that primarily serves preK-to-high school students access to high-quality education.
